This executive summary of the School Accountability Report Card (SARC) is intended to provide parents and community members with a quick snapshot of school accountability. About This School

Celerity Troika (grades K-8), first opened its doors on September of 2007. For its first academic year (2007-2008), it was located in a building next to the Celerity Nascent campus in Jefferson Park. For its second academic year (2008-2009), the location has permanently moved to 1495 E. Colorado Blvd. Los Angeles 90041. The original 100+ Celerity Troika students were merged together with Celerity Nascent's students for the 2008-2009 academic school years and Celerity Troika's new location was able to then start up with 98 newly enrolled students coming from the surrounding communities of Eagle Rock, Highland Park, Elysian Park, Cypress Park and Echo Park. Celerity Troika offers parents a more "personalized" school experience, with smaller class sizes that allow the teachers to focus on their individual students. Celerity Troika doubled its enrollment for the 2009-2010 academic year with 208 students.

Celerity Troika Charter School is also proud to announce that as of January, 2009 they have become fully accredited by the Accrediting Commission for Schools, WASC (Western Association of Schools and Colleges). WASC's accreditation process is all about fostering excellence in the education programs they accredit by helping the schools to meaningfully create the highest quality learning experience possible.

WASC's fundamental purpose is to support schools in creating for themselves a clear vision of what they desire their students to learn and are capable to accomplish and then to ensure that efficient and appropriate systems are in place that inevitably result in the fulfillment of those expectations.

All school personnel have pre-designated duties and responsibilities to assume in the event of a major disaster; earthquake, fire, lock down or other determined emergency. All CTCS employees automatically become Civil Defense Workers upon declaration of a disaster or state of emergency.

The emergency plan was created to assist the administration and staff members should a disaster occur. The first and foremost objective is safety of the site's students and personnel.

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Most CSU campuses utilize local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Professional Development

Prior to the beginning of every academic year there will be six days of paid faculty training aimed at developing standards-based curriculum guidelines and lesson plans.

There will also be four additional "Professional Development Days", throughout the year to be held as follow up sessions. These opportunities provide the staff to meet together for a full school day to work on creating thematic and integrated lesson plans. Teachers will also meet every Wednesday at the end of the school day to prepare for common planning, analyzing of student work and to evaluate status of targeted goals identified on prior full day professional development days.

XIII. National Assessment of Educational Progress

National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the [National Assessment of Educational Progress](#) Web page (Outside Source).

Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses

grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
